

TERMS & CONDITIONS OF LICENCE AGREEMENT

By submitting this completed and signed Application Form to Music Rights Malaysia Berhad (1207563-P) ("MRM"), you, identified as the Applicant in the Application Form ("Licensee" or "You" and references to "Your" shall be construed accordingly) make a contractual offer to MRM to be granted a non-exclusive licence limited to Malaysia to do the Controlled Act at Your premises stated in the Application Form ("Licence") and to pay the Licence Fees for the Licence ("Offer").

Subject to what is stated hereinbelow, MRM accepts Your Offer on the date when it receives this completed and signed Application Form and thereby, grants to You the Licence upon the following terms and conditions ("Additional Licence Terms") and the Standard Terms & Conditions, all of which You unreservedly accept are binding on You:

1. The Standard Terms & Conditions are found at MRM's website www.mrm.my or may be requested from MRM. You confirm that You have read, understood and agree to each of the Standard Terms & Conditions
2. Words or expressions defined in the Standard Terms & Conditions have the same meanings when used in the Application Form and these Additional Licence Terms
3. You shall complete the Application Form in full, providing all the details and information requested by the Form, truthfully and correctly. If You fail to do so, MRM may refuse Your Offer or if MRM has already accepted Your Offer before becoming aware of your failure to comply with this term, You shall be liable to pay MRM the Licence Fees at the higher rate according to MRM's prevailing published licence tariffs strictly within the time as stipulated in MRM's invoice
4. The grant of the Licence is premised on the Licence Agreement arising from and binding on You upon MRM's acceptance of Your Offer. The terms of the Licence Agreement are the Standard Terms & Conditions and these Additional Licence Terms. A primary term of the Licence and Licence Agreement is Your timely payment of the Licence Fees
5. The provision of Music Usage Reports is required and You agree to provide the same in accordance with the Standard Terms & Conditions
6. All rights not expressly granted by the Licence are reserved to MRM
7. The Licence Agreement and the Licence shall be deemed to have commenced on the Commencement Date and shall continue from Licence Year to Licence Year until terminated in accordance with the Standard Terms & Conditions
8. You agree that MRM is vested with authority, power and mandate by its members to grant the Licence and to enter into the Licence Agreement with You and, further, that MRM licences the Works and collects the Licence Fees as a declared licensing body pursuant to the Copyright Act 1987

9. MRM reserves the right to revise the licence tariffs from time to time as it considers fit, taking into account considerations including inflation, preceding calendar year's Consumer Price Index as published by the Department of Statistics, Malaysia, administrative costs and costs of doing business.

- Application must be supported by a copy of company's business registration and /or premise licence issued by the relevant local authority.

This Application is accepted when MRM receives the completed and signed Application. Such acceptance creates a binding agreement based on the Licence Terms between the Applicant and MRM. MRM may in its discretion refuse to accept the Application if the information provided by the Applicant is false, inaccurate or incomplete or for any reason that justifies refusal by MRM.
